#### **A Celebration of Hope**

Back in 1925 the old Tyler Park Club started Christmas tree lighting ceremonies in the park. The old storm-damaged cedar by the smaller set of tennis courts is believed to be one of the trees planted in those ceremonies. This year, ninety-one years later, TPNA revived the custom with a ceremony called the Celebration of Hope.

First, we had to get a tree. Thanks to stellar efforts by Martha Berner at Metro Parks and the good people at the Olmsted Parks Conservancy, a beautiful red cedar was planted on the lower slopes of the sledding hill near Tyler Park Drive. Our new tree is about seven feet tall, and it is expected to reach a height of 35 to 60 feet.

The ceremony itself took place in the early evening of Sunday, December 18. About a dozen people met to decorate the tree and celebrate the idea of light shining in winter's darkness. Due to a scheduling problem, the priest for St. James and St. Bridget was unable to attend, but the Congregation Adath Jeshurun was represented by Cantor David Lipp and the Louisville Islamic Center by Imam Mohammed Iqbal.

Cantor Lipp remaked that Hanukkah and Christmas Day coincide this year, and that another evergreen, the olive tree, was the symbol of peace in the story of Zechariah. Imam Iqbal gave a prayer of peace in Arabic and translated into English. We shared tea lights and candles while several others offered their thoughts. We embraced and left the newly-lit tree shining in the dark.

Now that we have a start, the plan is to keep going. Let us know what you would like to see next year. We have discussed lights on the bridge and encouraging decorations in the homes around the park. With the lessons learned about scheduling we will try to increase the number of congregations represented, and maybe add some music. The lesson, though, will stay the same: hope is always present when people of good will come together.

#### **Trees Delivered**

The previous issue of *The Neighborhood Bridge* promised a campaign that would start our recovery from disastrous tree canopy losses. The community delivered; we are coming back.

Seventeen homes received a total of twenty-three trees that in time will deliver nearly an acre of shade. Overhead lines and small front yards on our target streets kept us from planting as many large sized trees as we would have liked but fifteen of the trees have the potential to reach a height of 50' or more. The new canopy will be diverse, with twelve different species planted.

It was a good first year effort and, given its late start, it was downright magnificent. Credit for that belongs with our grant writer and chief salesperson Jo Shipley, our project manager Katherine Moberly, our caterer Stephanie Callen, our transportation specialist Clark Cox, who also made a cash contribution with his wife Kathy, and the community at large.

Other neighborhoods helped us. Josh White from Highlands-Douglass lent his expertise. Greg Fleck, Robin Blackshear, and Jim Schorch from the Original Highlands gave generously of their time throughout the process.

Special mention goes to the Green Teams from the St. James school who showed up in force with their adult leaders Melissa Rue, Shelby Thomas, and David Doll to distribute mulch on planting day.

Area high schools brought fourteen of the 37 volunteers who joined us for the planting day: a teacher and ten students from Assumption, two students from Manual, and one from Waggener.

Tyler Park neighbors who turned out to dig included Ed Kruger, Ernst Trachsel, Greg Guelda, John Callen, Jorge Zenil, Margaret Gerstle, Jim Gerstle, Mike Gramig, and Stephanie Reilly. Highland Coffee donated the coffee, Boombozz Pizza gave us lunch, and the Louisville Water Company donated water bottles for our volunteers.

A grant from MSD paid for the expenses of the campaign, along with suggested donations of \$25 per tree from those who received trees, plus cash donations from some extraordinary people who could not plant a tree this year but wanted to help. Thanks to Alice Boyer, Joe Burnett Jr., Anita Chambers, Ray Griffith, Brian Phillips, and Andy Sims.

Neighbors also helped out by posting signs for the campaign: Ken Baker and Roy and Alyce McDonald on Tyler Park Drive; Ron and Jill Bath on Edgeland Avenue; and Bill and Terry Redden and David and Mary Beth Zickel on Edenside Avenue.

Going forward, we have a seasoned team, marketing materials we can re-use, and funds that can provide self-insurance against tree losses in the coming years. Plus our twenty-three new arrivals, filtering our air and water and growing new canopy. Downright magnificent.

### These Twenty-Three Young Trees Grow in Tyler Park Neighborhood

Below are public domain photos cropped and sized of the 23 types of trees we planted. The sizing is their height at maturity, scaled 2/10 of an inch to ten feet. So a tree that will grow to 70' is pictured in an image 1.4" tall. Some of the images are repeated to represent multiple plantings of the same type of tree. Three redbud images for the three redbuds we planted, for example.

#### **Comprehensive Planning**

Imagine a place where people have to stop, unload, and reload before going further upriver. Things will stack up, a town will form, and the town will eventually grow into a city. That will happen without much planning. But imagine instead you already have a city and things are moving a bit faster than in the steamboat days. For that you need comprehensive planning and given the speed of change, the planning has to look farther ahead. Louisville Metro government has invited citizens to join the planning process.

The first step was to assess where we have been and to predict where we can go, guided by citizen input on where we want to arrive. The result was the extensive report, Vision Louisville, with a specialized look at transportation called Move Louisville.

The years of effort in those two projects and other related work has been applied to give a meaningful context for a revision of the central planning document of our Metro government.

The current plan, called Cornerstone 2020, is "the framework for Louisville and Jefferson County's land development... the community's direction for future development and growth... [and recommended] policies and projects to achieve its desired results", as explained on the <a href="https://www.louisvilleky.gov">www.louisvilleky.gov</a> website. The Kentucky statutes require cities to have comprehensive plans and to revise them on a regular basis. Cornerstone 2020 was adopted in June, 2000 as a long range plan for the twenty-year period whose end we are now approaching.

The Mayor formed an advisory committee to guide development of the new comprehensive plan, and a general meeting for the public was held in November to organize the detailed work.

At this stage the public is participating in work groups to write goals and objectives for six topics: community facilities, community form, housing., livability and environment, marketplace, and mobility. Refer to the sidebar for information on the individual groups.

Public participation is vital. Every person who shows up brings a fresh view of our issues and the solutions we can create. Nothing says people can only come to one work group, either. Personal insight can inform the groups how the different topics relate. As a recent example, the closing of the 810 Barret government center (a point of discussion for the Community Facilities work group) creates a need for transportation from some of the old city neighborhoods out to the new government center in Middletown. — Ray Brundige, TPNA Board

Look there for the notes on the August 31, 2015 meeting, which has some basic information. The committee meets monthly, skipping December. The next public meeting will be on January 24.

There are six work groups, which are listed at <a href="https://louisvilleky.gov/government/planning-design/work-groups">https://louisvilleky.gov/government/planning-design/work-groups</a>. Each has its own page.

Community Facilities – This work group will focus on updating the Comprehensive Plan policies related to the location and design of public facilities including parks, government buildings, schools, utilities and non-transportation infrastructure such as water and sewer facilities.

**Community Form** – This work group will focus on updating the Comprehensive Plan policies that address the character and diversity of Louisville's neighborhoods by reviewing and updating the Form District descriptions and incorporating recommendations from the Historic Preservation Task Force.

**Housing** – This work group will focus on updating the Comprehensive Plan policies that address and advance the provision of and access to housing for all of Louisville's citizens.

**Livability & Environment** – This work group will focus on updating the Comprehensive Plan policies to enhance community health and equity, and incorporating sustainability into the Plan. The work of this group will be informed by Sustain Louisville, Healthy Louisville, and the Health Equity Report.

**Marketplace** – This work group will focus on updating the Comprehensive Plan policies relating to Louisville's business and economic growth.
