

A great day was had by all. We would be remiss if we didn't mention all the hard work that Metro Parks did to clean up the storm damage and make the park safe for the kids.

Metro Parks and the consultants continue their work on the new Master Plan for Tyler Park. By the time you read this, we will have had a 2nd public meeting on May 21st to present the preliminary results of historical research and the results of surveys conducted by the planners. There will be several more meetings to present initial concepts for the plan and gather feedback from the neighborhood. Then a final plan will be presented to the public. We urge all who are concerned about the park and its future to respond to the surveys and attend these meetings. Your input on how you use Tyler Park and what you would like to see in the future is needed. Stay tuned for the announcement of dates for future meetings which are held at the Louisville Free Public Library up at Mid City Mall.

Security is being beefed up in the park to try to prevent the **vandalism** that has been occurring. Councilman Tom Owens office, Metro Parks and Metro Police have all been contributing funding and personnel resources to stem the tide of graffiti. It is a continuing and frustrating fight that requires all of us

to confront and report perpetrators. Parks has already painted the bathroom shelter twice this spring.

Coming up we have the annual **Tyler Park Garden Tour** chaired by Jeanette Westbrook. Please note that there has been a change of date. It will be held a little later than usual on Saturday, June 27. Get the particulars in an article on the Garden Tour in this issue.

Neighborhood Conservation District

On March 19, proposed revisions to the Landmarks Ordinance were introduced at the regular meeting of the Louisville Metro Historic Landmarks and Preservation Districts Commission. The revisions would allow a new category called the Neighborhood Conservation District which would be similar to the Historic Preservation District and the process for both districts would be similar. Some in the community have designated this concept as "historic preservation lite" as it is not as strict as current historic preservation districts.

This proposed ordinance revision is enabling legislation for the concept. The proposed general district guidelines are currently being drafted by Charles Cash and Richard Jett, staff at the Landmarks Commission. Once these general guidelines are reviewed and approved by the Commission, the proposed ordinance would go to Metro Council for consideration.

Conservation zoning is a planning tool to protect the architectural character and historic fabric of the neighborhood having this designation by managing growth and change. This category would be similar to an overlay zoning district. Each neighborhood, through its residents, would have to determine their interest in this district and each district would be created after extensive public input and approval by ordinance for each district designation.

Since no details exist at this time, the following are general concepts pertaining to conservation districts. This designation protects from the loss of architecturally or historically important buildings, new construction not in character with the neighborhood, and additions to buildings that would decrease their architectural importance. Plans would be required for demolition, new construction, additions and relocation and reviewed by an architectural review process and the Commission staff. These reviews would be based on the design guidelines approved by the neighborhood prior to the designation of a district. The exact process and guidelines are being determined and the community will have an opportunity to be involved and comment at a scheduled public hearing.

The idea of this district is not new and is in place in various communities throughout the country. Nashville has had such a designation since 1978. The Phoenix Hill neighborhood, after losing one historic building after another, began looking for a possible solution less strict than the historic preservation designation. Once learning about this possibility, the neighborhood association approached David Tandy for assistance. The Office of the County Attorney drafted the ordinance and the Landmarks Commission has had its first reading. 

### Side Walk Repairs



Councilman Tom Owen's administrative assistant notified the TPNA board that there were funds available from the Federal Stimulus bill to

repair existing sidewalks. Only existing sidewalks are eligible. A few board members walked the neighborhood to identify and collect addresses that appeared in need of sidewalk repair. The addresses were then turned over to Terra Long, Councilman Owen's administrative assistant. Shortly after, inspectors surveyed the addresses submitted and subsequently painted those sidewalks deemed in direst need of repair with white marks. No word yet on when the repairs will be made, but our understanding is that they will be done before year end.
