#### TYLER PARK NEIGHBORHOOD FESTIVAL - SEPTEMBER 13, 1992 HISTORIC TROLLEY TOUR - MUSIC - RESTAURANTS - RAFFLE

The Tyler Park Neighborhood Festival will be held in Tyler Park on Sunday, September 13th from 3-7 P.M., with a rain date scheduled for the next Sunday, September 20th. The Festival is sponsored by TPNA and supported by Sharps (Non-Alcoholic Beverage). Sharps is providing funds for entertainment and help with signs for participating restaurants, shopkeepers and TPNA booths.

A variety of entertainment will be featured including John Gage (Folk Musician-children oriented) from 3:00-4:00 P.M., in the pavilion, Jack Ashworth (Violinist) and John French (Dulcimer) from 4:00-5 P:00 P.M., in the upper park and Da Mudcats (Blues) from 5:00-7:00 P.M., in the pavilion in the lower park.

Neighborhood restaurants will be providing the festival fare and will be set up on the upper side of the park. The following are confirmed participants: ALAMEDA, PASTA PIZZAZZ, THE OLD WALNUT CHILE PARLOR AND KIZITO COOKIES. TPNA will be selling soft drinks and Sharps beer. ALBERT FRAMING AND JEWELRY, SUSAN'S CORNER, SWANSON/CRALLE GALLERY AND STEVE HENRY will be participating at the festival.

TOM OWEN has agreed to provide historic tours of the Highlands. Tours will be conducted on TARC Trolleys which will run between 4:00-6:00 P.M. from the park.

TPNA will have a membership booth selling association memberships, TPNA mugs and shirts as well as tickets for the trolley tours. TPNA will also have a Raffle. Raffle items will be displayed and tickets will be sold for raffle drawings during the festival.

The Tyler Park Neighborhood Festival is an event for the whole family and one that will bring many neighbors together to enjoy our park, our local restaurants and shops and some wonderful entertainment. Don't miss it!





#### YEAR-ROUND HOUSEHOLD HAZARDOUS MATERIALS COLLECTION

The third annual Household Hazardous Materials Collection program is being offered six times during 1992-93 at different sites.

City and County residents can bring any toxic, ignitable, reactive or corrosive materials from their homes, garages or basements to the sites for proper disposal. Wastes from business or commercial operations won't be accepted in the program.

Some of the items collected last year were paint, toilet and drain cleaners, silver and brass polishes, oven cleaners, herbicides, pesticides and pool chemicals. Dates and locations for sites are:

#### STATUS REPORT ON 1858 EDGELAND AVENUE

In case you're one of the many who have expressed concern about the appearance of the house at 1858 Edgeland Avenue at the corner of Bardstown Road, here's an update:

On July 22, 1991, the city cited ten violations found on the house at that address. The violations included: falling gutters; damaged rear porch, steps and guardrail and front porch balusters; broken downspout; broken window; and uncollected trash. Since then, the owner filed a complaint against the city, saying a police car ran into the building and caused extensive damage. The owner also said that an insurance payment is due for the damages and that the building is for sale.

On August 18 of this year, the owner did not show up for a court date concerning the violations. The city filed a bench warrant against the owner, hoping to settle rather than send the case to District Court.

#### VANDALISM AND NOISE ARE PERSISTENT PROBLEMS IN TYLER PARK

The Tyler Park Neighborhood Association has received an increasing number of reports of vandalism in the Park. The new kiosk, erected for TPNA messages, has lost its glass case and locking doors. Doors, lights and hardware have been damaged in the restrooms. If anyone has any information leading to the arrest and conviction of persons causing this vandalism, the TPNA will pay \$200 for such information.

Members of the Board, the Park and Neighborhood Improvement Committee and nearby neighbors of the Park met with representatives of the 1st and 5th Divisions of the Louisville Police Department to discuss ways of reducing vandalism and troublesome noise after hours. The police are empowered to enforce existing laws on underage drinking and prohibition of alcoholic beverages in the Park. However, there is no law, yet, that requires park patrons to be quiet or to leave the park if they are engaged in lawful activities such as bongo-laying or basketball in the very late evening or early morning hours.

It was pointed out that Tyler Park is the only Park in the Metro Parks System not to have posted hours. On recommendation of the Board, the members of TPNA will vote on the issue of closing the Park between the hours of 11:00 P.M. to 6:00 A.M. There is no physical means of closing the park, but signs would be posted noting the hours. With such notification, the police can remove anyone from the park during the off hours.

A similar problem has arisen in the parking lot adjacent to Valvoline, where teenagers and young adults have gathered during summer nights. Valvoline has put up a strong light and a sign, stating "No Loitering After 1:00 A.M." This action seems to have abated the problem somewhat, according to police authorities.
