TDNA DUES - WHEN DID I LAST DAY??



From Commissioner Henry's Office

Congratulations to the Tyler Park Neighborhood Association and all the board members and volunteers for putting together another successful and entertaining annual festival! It was great to attend at this time of year, especially with the wonderful weather.

One of the attractive features of living in the Tyler Park area is the park itself. The open space with tennis courts, swings, and picnic areas situated between busy intersections is very welcome.

Unfortunately, in the past 25 years, newly developed park space in the 'A' District has been minimal. From 1945 - 1969, a total of 1,073.3 acres were developed into park space. However, from 1970 until today only 176.73 acres have been developed, with 29 acres taken away for the Gene Snyder - Hurstbourne Lane expansion.

On the positive side, Commissioner Henry has called for a new east end park. Although commercial and residential development is on the rise in 'A' District, no land has been set aside for new park space. It it important to preserve the beauty of our undeveloped land so that scenic parks can be built for all Jefferson County residents to enjoy.

The Schuster Building

The fabulous renovation of the Schuster Building will soon be complete with the addition of a two-faced clock from the Verdin Company, one of America's oldest clock manufacturers. The clock will be placed on the third story facing Bardstown Road and wil' be the same size as the third story windows. Installation should be completed in two to three weeks.


The prominent firm of Nevin, Wischmeyer & Morgan designed the building in the Colonial Revival style to serve the growing suburban population of that era. The building originally housed shops, professional offices, apartments, and the Uptown Theater.

Almost 70 years later, the charming and eclectic Highlands area still embraces the unique Schuster Building. The street clock will add another dimension to a building that not only contributes to the character of Bardstown Road but also gives residents access to several great businesses.

Several of you have expressed concern about the future of the City-owned building at 1600 Rosewood Avenue, which has been occupied for quite some time by the Louisville Ballet. For several years, the Police Department has planned to take over the building and move a radio repair facility and associated office space into it. Although they did not get the necessary money in the City budget this year to do the extensive renovation they had proposed, they will still be moving operations into the first floor once the Ballet moves out. I am told the Police expect this to occur within the next couple months. (You may not be aware they use the old firehouse next door to the building, so this mopve will simply be an expansion next door.)









Louisville Youth Alliance

We are pleased to offer our support to the Louisville Youth Alliance, a program in the Department of Community Services. Its purpose is "to mobilize the community to ensure a responsible, healthy, productive adulthood for all youth".

The Alliance has five areas of focus. The community network collaboration and planning team sets policy and includes task forces on non-school hours, teen pregnancy and the prevention of youth violence. The public awareness team handles media and community relations and offers teens avenues for positive communication. The development team deals with funds, grants, corporate sponsorships, and awards. The jobs team offers training, internships, education and career counselling. The youth training and development team coordinates with Neighborhood Youth Boards and offers training in creative and personal skills.

Two key programs are the Louisville Youth Council (LYC) and the Neighborhood Youth Boards. The LYC gives teens (eighth grade through high school) a voice in community government. Meetings are held twice a month. The LYC sponsors entertainment, community service projects, and public relations. The Neighborhood Youth Boards are run by Peer Leaders who coordinate events for teenagers and adults, community service projects, leadership and development workshops and fund raising. A Peer Leader is a youth who has been extensively trained in communications, outreach, and organizing skills; and who has responsibility for NYB meetings and events.

The *Bridge* encourages you to participate in Youth Alliance activities. Teens can interact with community leaders to make a positive contribution to our city. With all of the negative forces in society today, that is certainly something worth your time.

Jeannette Westbrook brought in the entertainment. John Reilly and Greg Popham arranged the food and coordinated with the Parks Department. (By the way, our thanks to the Department for their help). A number of volunteers walked door to door selling raffle tickets and encouraging neighbors to attend.

The results were gratifying. Everyone seemed to enjoy themselves, particularly the children. The Association made some money. The people with booths made contacts or sales. The entertainers had enthusiastic audiences.

We had a few problems, caused by a need for earlier planning I missed the deadline for the *Senior Life and Times*, which I realized at the last moment would be ideal for advertising the Big Band concert. Poor Mary had to work twice as hard getting booths because of the short notice. Our main food vendor did not know TPNA was arranging the drinks, so their beverage sales cut into our fund raising. When we explained, though, they gracefully bowed out of the liquid refreshments.

The Board will now devote some time to the Festival at every meeting. The aims are to maintain quality, increase quantity, and decrease last-minute panic. Still, I think I will be quite ready for October next year when the time for our own Festival rolls around.

I may have more leisure then. The *Bridge* may not continue its close-to-monthly publication. I do not mind the editorial chores but lack the time for selling advertising. Ironically, I have recently received my first letters to the editor! Sean Delahanty asked when the next Operation Brightside pickup will be. It will be December 11. Susan Newman wrote to ask about the replacement of the fence and the curved slide in the Park. I checked with Metro Parks. If current plans come to pass a decorative iron fence and a replacement slide will be in place before winter. Obtaining funds for the fence and finding a replacement for the slide have delayed the progress. The funds usually come from Metro Parks budgets; the Board of Aldermen can approve funds on special needs. For that matter, any public-spirited group or individual can contribute funds for park improvements.
