COMING SOON - EASTER EGG HUNT!

1,500 eggs will be waiting for your children to find them at the annual Easter Egg Hunt. Sponsored by your TPNA, the event is held on the east side of the park (tennis courts side) on **Saturday**, **March 29**, **1997 at 10:00 AM** sharp. Children through age 12 may participate. Egg hunters will be divided into three different age groups: ages 1 - 3; 4 - 8; and 9 through 12, with each age group having separate areas.

Children must have their own baskets or bags. Three eggs - one per age group - will contain identification for SPECIAL PRIZES.

The egg hunt will start at 10 a.m. promptly, so don't be late or it might be over. The event will take place regardless of the temperature and even if there is a light rain or snow.

LG&E PLANS WORK IN TYLER PARK NEIGHBORHOOD

Louisville Gas & Electric is planning significant work in the coming months in the Highlands, including the Tyler Park neighborhood.

LG&E is upgrading 100 year old gas lines on Baxter and Bardstown Road from Broadway to Douglass Boulevard beginning in March and lasting through the summer of 1997. The new gas lines will carry medium pressure instead of low pressure for greater reliability.

Gas services to homes and businesses will be upgraded, too, in an area that mostly affects the Belknap and Deer Park neighborhoods, but will also involve Royal Avenue and Castlevale Drive in the Tyler Park neighborhood.

Much of the work on Baxter and Bardstown Road will be done during off-peak hours, including nights, so that impact to businesses will be minimized. Work in residential areas will be done only during daylight hours.

All residential and business customers in the affected areas will be contacted to determine the most convenient time to change the service over and remove the meter to the outside where appropriate. There will be no cost to customers for this project, unless additional service is requested.

HISTORIC PRESERVATION

In a neighborhood, like Tyler Park, where residential streets are surrounded by commercial thoroughfares, like Bardstown Road, and partially commercial byways, like Baxter Avenue, it is important for residents to protect their interests. Witness the Cherokee Triangle, which in the 1970s was spiraling downward, but luckily was salvaged and then transformed back into the beautiful residential neighborhood it had been earlier in this century. This was done, as has been done in Tyler Park, by the hard work of homeowners who lovingly brought their often-remodeled homes back to single-family dwellings with historical features carefully restored and maintained. An integral part of the success of the Cherokee Triangle's revitalization was its designation as a Local Preservation District. Over the past twenty years, this status has enabled the neighborhood to prevent further commercial encroachment, stayed the demolition of older homes and provided free architectural design services to homeowners to modernize their homes without destroying the ambiance of a 100 year old neighborhood. Granted, there have been some controversies, but saving an historic Louisville neighborhood far overreached the few aesthetic arguments that occurred. Happily, most were worked out to the satisfaction of the property owner - a fact rarely reported in the news, though the initial conflict always is covered. There are no "preservation police." The only time the Historic Landmarks Commission inquires into some activity in a Preservation District is when they are requested to do so, usually by concerned neighbors.

In order to achieve Preservation District status, a neighborhood must vote with 75% approval. The area is reviewed to determine if it qualifies. Tyler Park overwhelmingly qualifies for this designation. It is already under the Highlands Historic District umbrella which is recognized as historically and architecturally significant. However, there is no intrinsic benefit to or protection by the designation. This is why we need to act now.

What do we have to gain? No more commercial encroachments, no more housing demolitions, increased property value and a sense of greater pride. (Think of Old Louisville.)

What do we have to lose? The biggest complaint seems to be that you cannot paint previously unpainted brick or masonry homes without approval from the Commission. The reason for this is maintenance. There is no restriction on the color you may paint your wooden house. By not acting now to preserve our neighborhood, we could lose corner lots to commercial use, followed possibly by the conversion of whole streets. (Think of Chenoweth Lane.) There is also the risk of property owners drastically and permanently altering the character of the neighborhood with unsightly additions and alterations. This has already been done in some cases. My own house is a strong statement against unsympathetic remodeling. There is no protection whatsoever for our homes, other than our own good taste. That is not enough. Unofficially, we are already a part of this public trust. Making it an official public trust ensures its place in the history of our city. I urge you to join me in this endeavor.

This is a unique opportunity. Please let me know if you are interested in this project. We would like to invite a Landmarks Commissioner to come out and talk to the neighborhood so that we can determine if this direction is where we want to go.
