City Café Coming to Mid City Mall

As reported by the Courier Journal on August 16th, Jim Henry's City Café will be opening an outlet at Mid City Mall. The restaurant will occupy quarters adjacent to the Baxter Theaters complex. The Tyler Park community welcomes Jim Henry's establishment and looks forward to the grand opening.

Your board represented our community interests at the land-use committee of the Jefferson County Planning commission on August 8th. Debby Donnellan, secretary of the TPNA board attended the open session and was instrumental in obtaining an order by the planning body that requires mall owners honor the terms of a 1994 legal agreement with Tyler Park neighbors to keep its doors open till mid-night so theater patrons can have access to the Bardstown road side of the mall. In addition, the mall will be required to construct a central walkway in the Bardstown Road parking lot to permit pedestrians to safely walk from the roadside to the mall. The walkway was included in the 1994 site plan approved by the Planning Commission for the theater development, but never constructed. Debby noticed the discrepancy and brought it to the attention of committee members. The walkway will be ready within 60 days according to the Courier Journal article. We wish to thank Debby for representing TPNA so successfully and The Mid City Mall management for bringing the City Café to our neighborhood.

Traffic & Bloom Elementary

The Jefferson County School System is progressing with their revitalization of Bloom Elementary. McCulloch Associates Architects has been hired to design the facility and are in the early stages of the design.

One of the factors that is a major concern with the schools location is student safety. Parking, traffic patterns and playground space all are part of a safe school environment. The District is developing a plan that separates car traffic from bus traffic and separates playground space from parked cars, all essential components of a safe school environment.

To accomplish this they are proposing buying the 1152 Bardstown Road property and converting it to a parking lot that will provide off street parking primarily for school staff. The current Bloom Elementary parking lot will be converted to a playground with no parking — no cars.

To separate bus traffic from parent drop off traffic, JCPS is proposing making the alley behind the school one-way east from Baxter Avenue to the alley that goes north and south between Lucia Avenue and Elwood Avenue. The parent drop off site would be behind the building and cars would use the one-way alley going east from Baxter Avenue.

In addition, JCPS is proposing making the alley between Lucia Avenue and Elwood Avenue one-way going north. This would move the traffic away from the school so the buses could go east on Lucia and drop students at the front door.

These proposals for the two one-way alleys will help assure our students are safe by keeping cars and buses at different drop off points. Elwood Avenue, Baxter Avenue, Lucia Avenue, and Bardstown Road would all remain two-way streets.

Changing these two alleys to one-way alleys will help the traffic flow significantly and provide a safer school for our children. The Tyler Park Neighborhood Association endorsed the JCPS plan.



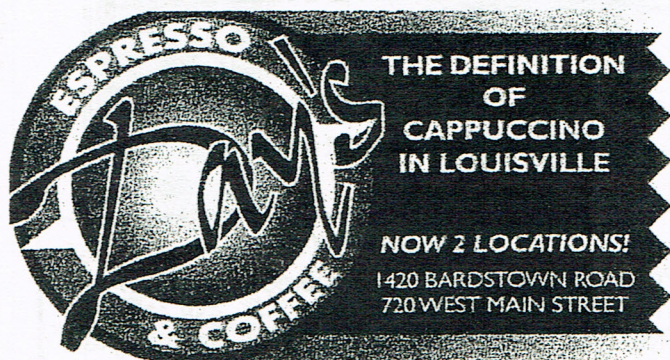
