



# Draft Tyler Park Master Plan

As previously reported, the parks department has contracted with Element Design to come up with a revised Tyler Park Master plan. There was a public meeting on April 16 to present the draft of the plan and solicit some input from TPNA and other residents. This was a preliminary plan that will be updated. Without getting into specifics major changes from the 2010 plan are:

- the two “historic” tennis courts will remain, with one possibly converted to a multi use court or a half court basketball court
- the other four tennis courts will remain and be resurfaced
- the tot lot and playground will be combined and moved to the lower part of the park and the spray ground relocated.
- the current shelter and restrooms will be demolished and new restrooms constructed on the same site, close to the playgrounds
- another shelter, to be used for large gatherings and concerts, will be constructed near where the current playground is located

The plan is currently being updated based on input from the April meeting. The TPNA has expressed concerns regarding the detail schedule of construction and coordination with the ongoing Tyler Park Bridge study and and other city departments; MSD etc. Since this plan is still not finalized the, TPNA has not formally endorsed it at this time. Our hope is that there will be other public meetings to further discuss the details. Plans were for construction to start sometime this summer. More updates to follow.

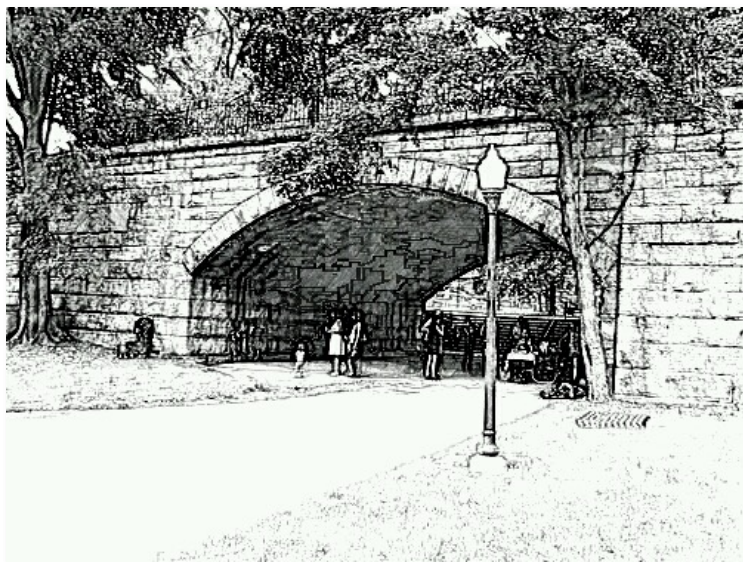

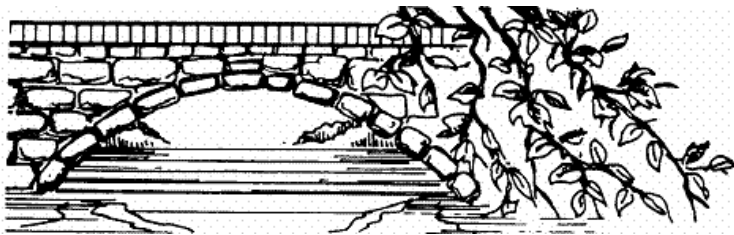

## Tyler Park Bridge Study

There is a Tyler Park Bridge/Viaduct repair study underway that is funded entirely by the state. This is a study of the entire structure to determine its current condition and direct future repairs. This effort is not connected with rebuilding of the park. It has been subcontracted by the state to an engineering company called Stantec. Stantec surveyed the bridge with modern survey equipment in February and March and has prepared very accurate drawings of the bridge and viaduct as a complete structure. They have also directly investigated the bridge portion of the structure using modern sonar and visual methods. There will also be borings through the surface of Baxter Avenue to determine the condition of the fill under the roadway.

There was a stakeholders meeting in late March to share the results up to that date. Generally the bridge is in reasonably good condition and the viaduct portion is also still aligned well. It is known that the mortar between the stones of the viaduct is deficient and that there is some degradation in the stone itself.

There will be a second stakeholders meeting when the condition report is complete. This is currently scheduled for late June. At that time the study will explain what work is necessary. Cost estimates will be available for the state to begin to consider funding repairs.

TPNA will be invited to the second stakeholders meeting when it is scheduled and will update the neighborhood on future plans for this vital structure. TPNA will also attempt to be sure that bridge repair work and the park rebuilding work are coordinated.

## Tyler Park: Neighborhood History

### The March of Progress

We know too much about our neighborhood to understand its history. Everyday we see the houses we know, where the people we know live. Everyday we see buses and cars and walk past telephone poles and under electrical lines. It was different when the neighborhood began, and the quickest way to learn that is to read newspaper articles from the early periods.

Look for the address of a house and you might find building permit listings like “Sallie S. Worthington, dwelling at 1403 Goddard Ave., \$3,000” or “J. J. Moore, concrete garage at 1313 Mossrose, \$550”.<sup>1</sup> Look for familiar names and you might find stories about relatives from long ago. (Be merciful with what you find).

While looking for houses and families you might find stories about buses or Louisville’s famous trolleys. Page 10 of the November 12, 1912 *Courier*, for example, features charming pictures of the inaugural run for the Oak street cross-town line, out Broadway to Cherokee Park.

The introduction of automobiles was not as joyful. Page 11 of the May 13, 1903 issue noted “the first litigation in the local courts” from an automobile accident. C. L. Riddle brought the suit against Dr. Alexander Nettleroth, whose new automobile had scared Mr. Riddle’s horse. The court ruled for the defendant. Later that year the *Courier* ran a feature with the headline “What Will Become of the Horses? Autos Pushing Them Aside”<sup>2</sup>

The answer was still open four years later: a list of “Licensed Automobiles, Auto Cars and Motorcycles in the City of Louisville”.<sup>3</sup> had less than 700 entries, and forty or so were marked (QUIT) – which we can guess meant potential licensees had decided to stay with their horses.

The first telephones here may have been the line connecting the office and grain elevator of Byrne & Speed. They were such a novelty that the January 15, 1878 *Courier* urged the public to visit the firm to “see it, 189 Jefferson street.”

Electric lighting was also first introduced for business, in an 1880 experiment at the Eclipse Mills.<sup>4</sup> The city followed late in 1881, and the Christmas Eve *Courier* reported that Santa Claus had made his rounds by electric light “on Fourth Avenue and on Market and Jefferson... [and in a display] at the Mammoth Clothing Store, which was ablaze with daylight, ten lights of 2,000 candle power strong.” People thronged to see it.

That actually sounds like the annual Light Up Louisville. Maybe our lesson is that understanding history is a matter of looking at the old as if it were new again. — Ray Brundige, TPNA Board

### Something Wonderful

Something wonderful is happening at the Mid City Mall. Actually, things wonderful are happening there all of the time, but something that has been happening there regularly since the fall of 2012 is exceptionally wonderful. Young people affected by autism are learning how to deal with the world.

They are doing so through services offered by the Bluegrass Center for Autism. BCA has an integrated instructional strategy to blend Applied Behavioral Analysis, speech therapy and life skill development with academic achievement and vocational training. Every young person at BCA receives one-to-one instructor attention in a program created to suit the individual’s needs.

BCA has two campuses. The Mid City Mall campus, managed by Program Director Beth Lipe, is in Suite 15 across from the Jewel Box and the Family Dollar Store. The east campus is at the Kosair Charities center, 9810 Bluegrass Parkway. They serve different age groups. “This campus helps learners aged twelve to twenty-one, so our focus is on life skills and vocational training,” explained Ms. Lipe. “The east campus is for children aged two to twelve and its focus is appropriate to their age group”.

Like its young clients, BCA is evolving. It began as a tuition-based school for children with autism and has become a medical therapeutic center that accepts insurance. That allows the one-to-one instruction to continue, and broadens the availability of the services. Although revenues are increasing, the support of the community is still essential. Fund raising campaigns make a difference.

The need is still greater than BCA can meet. There is a waiting list. Families have relocated to Louisville from distant states to take part in the program because it is successful in meeting the challenge of transition into a self-sufficient life. As the motto on Suite 15’s wall says, “Teach to Learn. Learn to Live” – and that’s wonderful. —Ray Brundige, TPNA Board

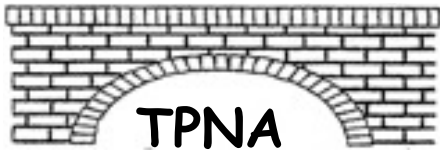
