Your Neighborhood Association is Planting Trees

Want to make a positive impact during the Coronavirus? Keep calm and plant trees with us on October 24th.

A comprehensive tree study completed in 2015 found that Jefferson County is losing an average of 54,000 trees per year. Every neighborhood experienced a decrease in tree canopy between 2004 and 2012. The Tyler Park neighborhood had the second highest loss of tree canopy at 24% decrease.

Recognizing that more trees can be planted sooner and at less expense by utilizing volunteers coordinated through neighborhood associations, MSD is funding tree planting grants of up to \$240 per tree to neighborhood associations across Louisville. Utilizing MSD funding, the Tyler Park committee is planting 25 trees in front yards on Tyler Parkway, Edenside Ave, and Edgeland, Goddard and Rosewood. These streets were chosen for their noticeable lack of trees on the urban heat island map. Next year we will expand our efforts to include more streets, as well as backyards.

In an effort to ensure a successful tree planting project, the Tyler Park committee has joined the Highlands Tree Initiative, a consortium of Highlands-area neighborhood associations that are committed to help make the Highlands greener and more sustainable by increasing the urban tree canopy. Led by Josh White, this collection of tree planters promotes best practice tree planting in the Highlands.

We are recruiting volunteers to help with our planting on October 24th, and provide ongoing support through our tree steward program. Per COVID guidelines, it's recommended that volunteers come from the same household. So, this will be a great opportunity to get the family out for some physical activity. TPNA committee members have surveyed neighborhood streets for potential planting sites. Planting a tree is totally voluntary and owners have a choice of trees that are:


- •Easy to grow and maintain
- •Native to Kentucky whenever possible
- Resistant or tolerant to diseases and insects
- •Have outstanding ornamental and /or shade value

Trees benefit our neighborhood and our city in many ways. The National Arbor Foundation lists the following reasons to plant a tree:

Trees Increase Property Values – According to the Arbor Day Foundation's research, "83 percent of realtors believe that mature trees have a 'strong or moderate impact' on the salability of homes listed for under \$150,000; on homes over \$250,000, this perception increases to 98 percent." A mature tree can have an appraised value between \$1000 and \$10,000

Trees Save Energy – Depending on how your home is sited on your property, trees can provide shade during the heat of summer or protect your home from the winds in winter. According to the U.S. Forest Service, "trees properly placed around buildings can reduce air conditioning needs by 30 percent and can save 20 to 50 percent in energy used for heating."

Planting Trees



Trees Clean the Air –U.S. Forest Service research states that through photosynthesis, the average tree in a residential neighborhood will annually clean about 330 pounds of carbon dioxide from the air as well as provide enough oxygen for a family of four.

Trees Help Reduce Global Warming – Trees reduce the emission of carbon dioxide (by decreasing energy needs) and then absorbing the carbon dioxide released from our cars, homes, and power plants.

Trees Decrease Flooding – Trees reduce flooding by helping to reduce runoff. A typical 25-inch diameter maple tree will intercept over 2,000 gallons of storm water runoff annually.


Trees Improve Quality of Life – Trees create relaxing, beautiful, healthy spaces, absorb traffic noise and increase privacy.

Trees Provide a Natural Habitat - Native trees provide berries, seeds, fruits or nuts for local birds and wildlife.

Trees Strengthen Communities – The involvement of people in the planting and care of local trees can help build a stronger sense of neighborhood and civic pride.

Rebuilding Tyler Park's tree canopy is a multi-year, ongoing effort that will require many volunteers. We are recruiting volunteers to help with publicity, planting, and provide ongoing support through our tree steward program. In other tree news, a tree owned by Phyllis Costello, a Tyler Park resident, missed by only inches in becoming the State Champion white ash tree according to the Kentucky Department of Forestry. The state champion designation is given to the tree that is largest specimen of its species. Kudos to Phyllis for her devotion to maintaining this beautiful, 200- year old tree that shades three homes.

Tyler Park Alley Beautification

Tyler Park Neighborhood Association is in the early stages of partnering with Beargrass Thunder on alley beautification project that will include not only cleaning up our alleys but improving the surrounding ecosystem using native plants. The objective is to make our alleys, safer, and a source of pride that will enhance our community to bring us together. In the long term this will connect us with other neighborhoods.

Your Tyler Park Board took the initial step of conducting a survey of 5 alleys: Eastern Pkwy & Edenside, Edenside & Edgeland, Edgeland & Tyler Pkwy, Tyler Pkwy & Windsor, and Windsor & Rosewood. Once an alley is selected for a makeover alley neighbors will work together to:

- ·clean up the alleys,
- ·eliminate and replace invasive species
- ·plant some colorful, beautiful native plants in neglected spaces
- hang plants if the space can accommodate hanging plants
- ·paint murals or hang art on fences, retaining walls, and garages · max size of 20'x 20'
- stencils or drawings that can be colored in by neighbors of all ages completing murals, or
- ·professional commissioned/sponsored murals
- · smaller pieces of art can also be hung to decorate blank spaces

Beargrass Thunder will bring in native plant experts for a master class on the planning and maintaining the perfect ecofriendly, low maintenance alley garden. And they will also have a "how-to" class for our neighborhood muralists to kick off the project.

Your neighborhood association will seek grants and donations for drawings, paintings, plants, etcetera, and create murals – both professional/ commissioned murals and residents planned and executed murals – and other neighbor inspired artwork to make our alleys an extension of our neighborhood that everyone can enjoy. We want this to be an activity that neighbors of all ages can do together and have some fun. Let's start something BIG in Tyler Park!!

Century Marker

The Tyler Park Neighborhood association is excited to launch our Century Marker initiative.

The TPNA Century Marker recognizes Tyler Park structures, one hundred years old or older that have retained their historic charm. The structures must be well-maintained and contribute to the streetscape and neighborhood.

What is a century marker?

The marker is a rectangular bronze plaque measuring 5 inches by 3 inches. Its cast with the TPNA bridge logo designed for the exterior of a house or building. It signifies recognition by the TPNA of the structure's historical significance. The word "marker" derives from the 15th century term "to make your mark" and uniquely distinguishes the property and it's significance to the neighborhood.

How do you qualify for a century marker?

Owners must determine the date of construction of their house or building by researching the history of their house in order to confirm the house is 100 years old.

Most houses' age can be found by visiting https://jeffersonpva.ky.gov/property-search/ or by visiting the Jefferson County Clerks Deed room located 527 W. Jefferson St., Room 204 Louisville, KY 40202

Once age has been determined please send a copy of the report to <u>VP1@TylerPark.org</u>

What are the benefits of the marker program?

The TPNA Century Marker informs the public and neighbors about the age of a structure and its association with the Tyler Park Neighborhood. The presence of a marker also indicates that more detailed information about that structure is available in the archives of the Jefferson County Clerk's Office.

What does a marker cost?

The cost of a marker is \$100. The plaques are made in Louisville by skilled craftsmen who pour molten bronze into sand molds. Due to this process, makers will be available after fifty homeowners have purchased. TPNA anticipates markers will be delivered once per year.
