### "Sundays in September" Jazz Fest

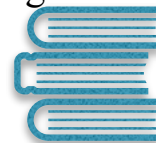

## View From the Bridge: Ribbon Cutting Ceremony for Tyler Park Sports Courts Restoration

On Saturday, September 3<sup>rd</sup> Mayor Greg Fischer accompanied by 3 generations of the Cooper family performed the ceremonial ribbon cutting in front of hundreds of attendees. Our President, Shawn Reilly, presented a check in the amount of \$50,000 to Layla George, President of the Olmsted Conservancy as partial payment for the over \$200,000 investment that the courts restoration represent. The Cooper family and Judge family Foundation were the other major contributors. TPNA raised the bulk of its contribution by reaching out to the membership, residents, and local businesses. Over 200 of You contributed to this effort, a feat that says a lot about where our collective heart is. The TPNA board thanks each and everyone of you.



The courts will be named for the Cooper family who years ago lived across the street from the courts on Tyler Park Drive and were such lovers of the sport that several of them became Kentucky's top tennis players in 1960's and 1970's. # How Did Beechwood Park Evolve?

Our neighborhood has always been a little bit off. Streets run at an angle, not straight east-west or north-south; the major roads have all changed their names at least once; the written records are not always clear. Being a bit off may help us live up to the “weird” label we enjoy, but it also complicates the job of pinning down our history.

Take the history of Beechwood Park.

The Park is on land that was part of an 1889 subdivision named Harry Stucky’s Highland Addition, once part of a one-thousand-acre plantation surveyed in 1774 for the Taylor family\*. Since the survey set its western boundary at right angles to the Ohio River shoreline, and Mr. Stucky set his Beechwood Avenue at right angles to the line, the subdivision’s street is at an angle, 53° east of due north.

The subdivision plan forces more mental adjustment. We picture Beechwood running west from Baxter Avenue to Bardstown Road. The roads had different names, though, when Mr. Stucky drew his plan in 1889. The road to the Von Borries mansion was on the west and the stretch of the Bardstown turnpike renamed in 1871 to honor Mayor John G. Baxter was on the east. The names we use did not go into effect until a city-wide 1909 effort cleaned up street names and addresses.

After we adjust our thinking, the challenge is to learn how a part of Mr. Stucky’s subdivision became a neighborhood park that featured the foundations of lost homes. Local memory outlines the key events, but the details have to be reconstructed from the written record.

The events outline started roughly 120 years ago with the building of an orphanage, the German Protestant Orphans Home. It was just south of the subdivision, and opened in 1903. By that time most of the lots in the subdivision were occupied, as shown in this 1912 fire insurance map of the south side of Beechwood. (Note the pre- and post-1909 address shown for each house). (Map on page 4 of TPNL)

The subdivision and orphanage passed another fifty-some years before an investment group envisioned a suburban-style mall in walking distance of our urban neighborhoods. The orphanage sold its land and moved to a site just past the Watterson. The investors cleared the site but could not finish the deal. A second group, Mid City Shopping Center, Inc., took over and built a new plan that included a bowling alley with adjacent parking in a side lot. Seven houses and their outbuildings on Beechwood were torn down to clear the way.

The other owners, however, were not happy, and they took their case to the mayor. The details have eluded the written record, but the result is the parking area next to the Back Door Lounge, its surrounding concrete block wall, and the patch of old lawns, sidewalks, and steps along the northern side of the wall that became Beechwood Park.

The meeting with the mayor was in October, 1962, and the space along Beechwood simply kept its status quo until the fall of 2013, when conversation at a front porch party across the street “sparked an idea [for] converting the lot to a pocket park for the public.

With help from the lot’s owner, the neighbors formed a charitable organization named The Friends of Beechwood Park, signed a long-term lease, and partnered with the landscape architecture firm Gresham Smith & Partners to plan their vision for the space.

Since then, the Friends have built alliances with TPNA and other local groups, raised funds from private donors and local government grants, and sweated – a lot – to move Beechwood Park toward its envisioned future.

**Go there. Sit on one of the benches. Imagine its history. If you want to connect to the local vibe of being a bit off, meditate on the idea that you may be sitting in someone’s living room.**

## Bump Outs and Tree Wells, Oh My!



Love it or hate it, Bardstown Road is getting a make-over. The project underwent years of research. It spans from Broadway to Bonnycastle. The redesign will make the street safer, more accessible, and more beautiful. It will be a street for people. Unused utility poles and the “ping-pong” lights have been removed eliminating visual clutter. New bump-outs and cross walks are being added. Sidewalks at intersections are being redesigned. The bump-outs will be planted with various plantings by Friends of Bardstown Road. Bus stops are being improved to make transit run more seamlessly. Tree wells are being added and over one hundred trees will be planted by TreesLouisville. The tree wells and bump-outs will be maintained by a contractor paid by Friends of Bardstown Road. ## **Street Numbers**

The TPNA Board made some hand deliveries throughout the neighborhood lately, to get the newsletter delivered before our Independence Day celebration and to thank donors who gave to the Tyler Park Fund. In the process we remembered a lesson from days past: we need to improve how we display street numbers.

Based on feedback from volunteers and what I personally saw, there are homes whose addresses are hidden away at the back of a deep porch, and homes whose addresses are in shadow, or too small, or simply missing. It is worse in the alleys.

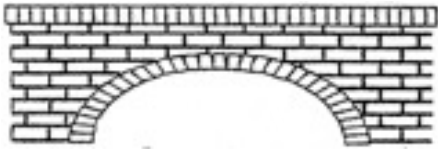
It complicates deliveries for groceries, packages, pizza, and the important stuff from TPNA. It complicates visits for guests invited to dinners and parties. It adds travel time to service charges for plumbers and other trade. It can delay responses by fire, police, and EMS.

There is a statute in Chapter 97 of the Metro Ordinances, Posting of Address Numbers, available at the American Legal Publishing site that Metro Government uses:

The addresses should be clearly visible, Arabic numbers on contrasting backgrounds, for both the street and the alley. Check the statute for details.

**Do yourself a favor and look at your home with the eyes of a first-responder trying to find the emergency location. Don't forget the alley.**
