During the pandemic years, our city's ordinance prohibiting short-term rentals within 600-feet of another was poorly enforced, if not ignored. Thankfully, it's a new day. Loopholes in the original ordinance have been closed and the Board of Zoning Appeals is making the right decisions.

As our 5<sup>th</sup> Division police officers work hard to control overnight, bar-related crime we continue our partnership with the Original Highlands Neighborhood Association to fight new 4 a.m. liquor licenses in the Baxter Avenue/Bardstown Road corridor. Deciding it would be better to go with a 2 a.m. closing time than open a new business in conflict with the community, Beyond the Sun, the new restaurant and lounge in the old Mellow Mushroom property, deserves credit for withdrawing its application for a 4 a.m. license. This came after a trifecta of strong opposition letters to the Kentucky Department of Alcohol Beverage Control from us, the Original Highlands Neighborhood Association, and the Cherokee Triangle Association. Beyond the Sun made the right decision and we appreciate it!

The officers will wear the trackers while patrolling on foot and the officer with the most steps logged in a week's shift will receive a gift certificate or complimentary meal from a 5<sup>th</sup> Division local eatery. The program's aim is to increase community interaction by having officers walking more frequently on the streets they serve.

Second Vice-President Paula Head had purchased the cards in late November following a resolution to show TPNA's gratitude to the men and women in blue.

# **Tyler Park Stage Update**

Olmsted Parks Conservancy- Jesse Hendrix Inman

Who is ready for some music in Tyler Park?

A generous gift to Olmsted Parks Conservancy has made it possible to build a new outdoor performing arts venue in Tyler Park. The stage is the last capital improvement of the Tyler Park Restoration Plan that was initiated in 2018. Olmsted Parks Conservancy and Louisville Parks and Recreation have invested almost \$1.5 million in the park since 2018. This new improvement will establish Tyler Park as a hub for performing arts in the Highlands. The stage will be the home base for the Tyler Park Jazz Series, and will provide more opportunities for festivals, concerts, and other community building events.

"The COVID-19 pandemic was so hard on local musicians and venues," says Olmsted Parks Conservancy President and CEO Layla George. "While the community rediscovered the importance of the arts, we also renewed our relationship with the parks and their value as community-building spaces. The Tyler Park stage will truly connect nature and neighborhood and showcase the creativity that makes the Highlands so special."

"The Highlands has always been a creative nerve center of our city, a place that has inspired countless artists and entrepreneurs like me to dream and do," says Forecastle Festival founder J.K McKnight. "To foster, grow and retain our creative class, we need public stages like this that attract, coalesce, and ignite our creative community. Like trees planted decades ago, it's important that we invest time and energy to replenish our neighborhoods with the assets that make them desirable places to live, work and play. Without Tyler Park, Forecastle Festival never would have happened. Today we turn the tide, open a new chapter, and reverse the trajectory. I'm excited for what that is going to mean for our artists, neighbors and community."

The stage will be located near the entrance of the park located at the intersection of Castlewood and Tyler Park Drive to take advantage of optimal acoustics and allow for easy load in/load out for performances. With this location, we also hope to limit additional vehicular traffic from entering into the park.

We are getting closer to starting construction on the newest stage in the Highlands neighborhood. The survey, design, and construction document processes are complete, and the project has gone out to bid. We anticipate selecting a contractor in the coming weeks and to begin construction this Spring. The project is expected to wrap up some time this Summer.




